City Council ordinance adoption generally occurs the 2nd meeting following the City Council public hearing where City Council directs Staff to prepare an ordinance.

This schedule is dependent upon the following criteria:

1. Complete application. Incomplete applications will not be accepted. Applications must be delivered by 12:00 pm on the scheduled submittal date. All applications must be hand delivered by the applicant and/or authorized representative (no couriers).
2. Applicant responsive to Staff's comments.
3. Timely resubmission to meet this schedule. The schedules will be extended if Staff's review comments have not been addressed and/or the applicant is late in resubmitting plans.
