SPECIAL EVENT INFORMATION

1. Fill out Special Event permit application completely. A site plan must also be submitted with the application.
2. Up to four (4) sidewalk sales and two (2) Parking Lot sales each calendar year, no more than seven (7) consecutive days. Sidewalk/Parking Lot Sale Permit fee is one hundred dollars (\$100.00). Written permission or a copy of the tenant's lease agreement that provides permission for a sidewalk/Parking Lot sale is required from the property owner and must accompany the permit application.
3. Up to five (5) temporary tent permits each calendar year. Permits are valid for two (2) consecutive weeks only. The temporary tent permit fee is seventy-five (\$75.00) for each temporary tent installation. Written permission or a copy of the tenant's lease agreement that provides permission for a sidewalk/Parking Lot sale is required from the property owner and must accompany the permit application. A Flame Retardancy Certificate must accompany each temporary tent permit application. A site plan clearly identifying location of tent must be provided.
4. A temporary outdoor seasonal sales permit is valid for a maximum of forty-five (45) consecutive days for each sale. The fee for a temporary outdoor seasonal sales permit is one hundred and fifty dollars (\$150.00).
5. Event can not encroach into require fire lanes or require parking.
6. If an applicant elects to serve or provide food and/drinks at the parking lot/sidewalk, a health permit must be obtained.
